Section 55 (4) (d) of the Road Traffic Regulation Act 1984 as amended by the Traffic Management Act 2004 (Financial Provisions Relating to Designation Orders) restricts what expenditure the Council can fund using car parking surplus if it is not required for further off street parking. - the purposes of a highway or road improvement project in the local authority's area,
- in the case of a London authority, meeting costs incurred by the authority in respect of the maintenance of roads maintained at the public expense by them,
- the purposes of environmental improvement in the local authority's area,
- in the case of such local authorities as may be prescribed, any other purposes for which the authority may lawfully incur expenditure;"
