NOTE RELATING TO THE ENTRY
 The Local Land Charges Rules 1977 (SI 1977 No. 985) provide for registration in Part 6 of the Register of Local Land Charges of entries relating to retained land and associated public works under Section 8(4) of the Land Compensation Act 1973.

This section of the Act provides that where an authority possessing compulsory powers acquires land for the purpose of any public works and the person from whom the land is acquired retains other land, particulars of the land retained and the nature and extent of the works shall be registered as a Local Land Charge. This action will not affect the property.

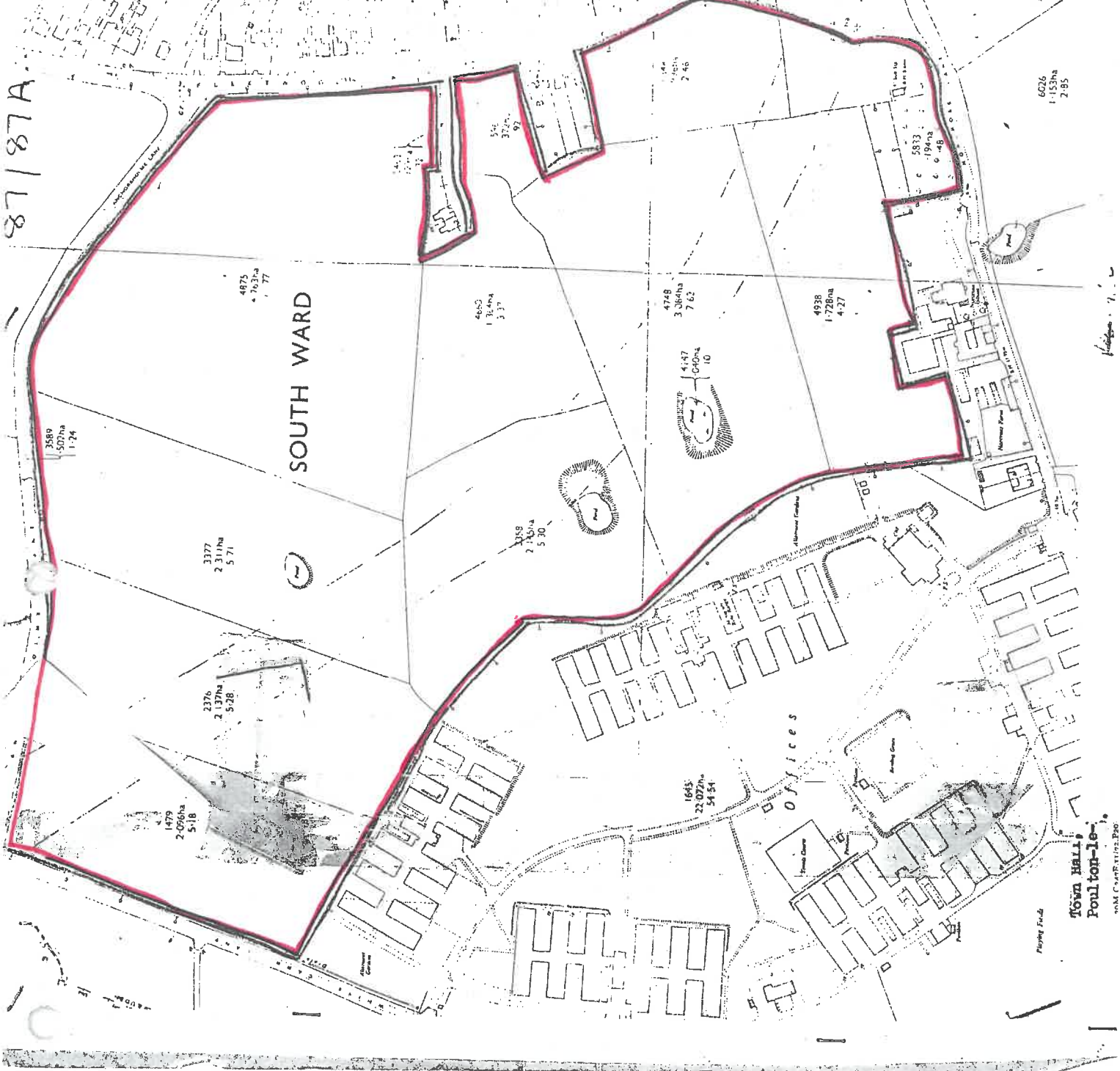
Section 8(2) provides that whether or not any sum is paid or payable in respect of injurious affection of the land retained, compensation shall not be payable under Part 1 of the Act in respect of any interest in that land. Registration is therefore necessary in all cases where the whole of the claimant's land is not being acquired, primarily to enable a prospective purchaser to know whether or not he will be able to make a Part 1 claim.
