(a) Steps required to be taken - "Reduce the depth of the canopy fascia to 0.46m (1ft.6in.) in accordance with the drawing submitted with Planning application 02/89/1427, which was approved on 15th December 1989 and remove all surplus materials from the premises.

(b) The deletion of the words "28 days" and the substitution thereof of the words "four months".
