## **Cemetery and Bereavement Services**

### **Memoralisation Agreement**

Wyre are lawned cemeteries. All graves will be level with the surrounding ground. Kerbs, borders stones, tiles, raised mounds, turf bankings, wooden, plastic or metal erections of any kind will be not be permitted.

Memorials, including all concrete foundations and plinths, must not exceed 3 foot 6 inches in height, 3 foot in width and 4 inches in depth.

An area of 15 inches is allowed from the front of the headstone no wider than the headstone plinth for personal memorialisation. If the grave owner wishes

Enclosures must be removable, No glass/ noise causing items, fast growing plants/trees or offensive items are permitted and will be removed without notice.

This 15 inch area may also be used for an engraved tablet or additional vases subject to a memorial permit being obtained from the Council.

The council have the authority to remove, without notice, anything placed on or around a grave which contravenes Borough Council current Rules and Regulations or the Grave space Memorabilia Policy.

The council will maintain the turf on each grave free of charge.

#### How we process your data?

Processing your data is necessary in the exercise of official authority vested in the Council.

Wyre Council (The Data Controller) will only use the personal details that you have provided to deliver the bereavement service and maintain the burial register. We may also contact you by either letter, telephone or email to discuss the requirements of the requested service. It should be noted that the data you have provided will need to be shared with third party organisations in order for this service to be delivered as agreed; namely your selected Funeral Director and/or Memorial Mason.

Your data will be stored on the burial registers indefinitely as part of the Local Authorities Cemeteries Order 1977 Article 11(2)b and Amendment Order 1986.

You have the right as the data subject to access your data. If you feel the data we hold is inaccurate or incomplete, you are entitled to have your personal data rectified. Please contact wyre.gov.uk for further information. You also have the right to contact the Information Commissioner if you are un-happy with how we are handling your personal data.
