3. Nomination papers must be delivered to the Returning Officer, Civic Centre, Breck Road, Poulton-le-Fylde, Lancashire, FY6 7PU on any day after the date of this notice but no later than 4 pm on Friday, 11th October 2024.
4. If any election is contested the poll will take place on Thursday, 7th November 2024.
5. New applications to register to vote must reach the Electoral Registration Officer at Civic Centre, Breck Road, Poulton-le-Fylde, Lancashire, FY6 7PU by Tuesday, 22 October 2024. You can register at www.gov.uk/register-to-vote
6. Applications, amendments or cancellations of postal votes and amendments or cancellations of proxy votes must reach the Electoral Registration Officer at Civic Centre, Breck Road, Poulton-le-Fylde, Lancashire, FY6 7PU by 5 pm on Wednesday, 23rd October 2024. You can apply for a postal vote at www.gov.uk/apply-postal-vote
7. Applications for a Voter Authority Certificate (free voter ID, or an Anonymous Elector's Document valid for this election, must reach the at Civic Centre, Breck Road, Poulton-le-Fylde, Lancashire, FY6 7PU by 5 pm on Wednesday, 30th October 2024.
8. New applications to vote by proxy at this election must reach the Electoral Registration Officer at Civic Centre, Breck Road, Poulton-le-Fylde, Lancashire, FY6 7PU by 5 pm on Wednesday, 30th October 2024. You can apply for a proxy vote at www.gov.uk/apply-proxy-vote
9. Applications to vote by emergency proxy at this election on grounds of physical incapacity or for work/service reasons must reach the Electoral Registration Officer at Civic Centre, Breck Road, Poulton-le-Fylde, Lancashire, FY6 7PU by 5 pm on Thursday, 7th November 2024. The physical incapacity must have occurred after 5 pm on Wednesday, 30th October 2024. To apply on the grounds of work/service, the person must have become aware that they cannot go to the polling station in person after Wednesday, 30th October 2024
