**Personal Local Plan ID:**

In September 2017 the council undertook a six week public consultation on the Publication Draft Wyre Local Plan. In response, the council received representations from 763 individuals and organisations.

The council submitted the Plan to the government on 23 January 2018 which was the start of the Local Plan Examination. Public hearings held from 15 May 2018 to 5 June 2018. In response to issues raised within the representation and by the Examination Inspector, and taking into account the Inspector's post-hearings Advice, published in July 2018, Main Modifications to the Local Plan are now proposed.

The council is now inviting representations on the Main Modifications to the Publication Draft Wyre Local Plan and the accompanying Sustainability Appraisal Addendum 2018 over a six week period from **12 September 2018 to 5.00pm 24 October 2018.**

**It is important to note that representations can only be made in relation to the proposed Main Modifications and the Sustainability Appraisal Addendum 2018. There is no need to repeat any previously submitted representation, nor can the council accept comments on aspects of the Local Plan not subject to a Main Modification.**

The Statement of Representations Procedure (overleaf) provides more details about the consultation. Once the council has received the responses we will submit the representations to the Local Plan Inspector for his further consideration. The Inspector will decide whether or not to re-open the public hearings into the Local Plan and will consider whether or not further modifications to address matters raised should be sought.

**Town and Country Planning (Local Planning) (England) Regulations 2012**

The Wyre Local Plan (the Plan) was submitted to the Secretary of State for Examination on 23 January 2018. Following the Examination in Public (EIP) hearing sessions from 15 May 2018 to 5 June 2018, the Inspector has requested the council to undertake consultation on the proposed Main Modifications required to make the Local Plan sound. This is without prejudice to the Inspector's final conclusions and recommendations on the Local Plan.

The proposed Main Modifications generally take the form of changes, deletions or insertions to policies and supporting text. Representations received relating to the proposed Main Modifications will be submitted to the Inspector for his consideration.

A Sustainability Appraisal Addendum 2018 has also been prepared and is available for consultation. The council is also publishing Additional Modifications which are of a minor nature and do not materially affect the policies set out in the Local Plan (e.g. factual updates and correcting typographical or grammatical errors). They are not necessary for soundness and as such are not part of the consultation.

**The consultation period is for six weeks, from 12 September to 5.00pm 24 October 2018 inclusive. The consultation is limited to the Schedule of Main Modifications and the accompanying Sustainability Appraisal Addendum 2018 ("the consultation documents") only. It is not an opportunity to comment on other aspects of the Local Plan.** If you submitted comments on previous versions of the Local Plan, the Inspector has considered these during the examination and there is no need to make these again unless affected by a Main Modification. 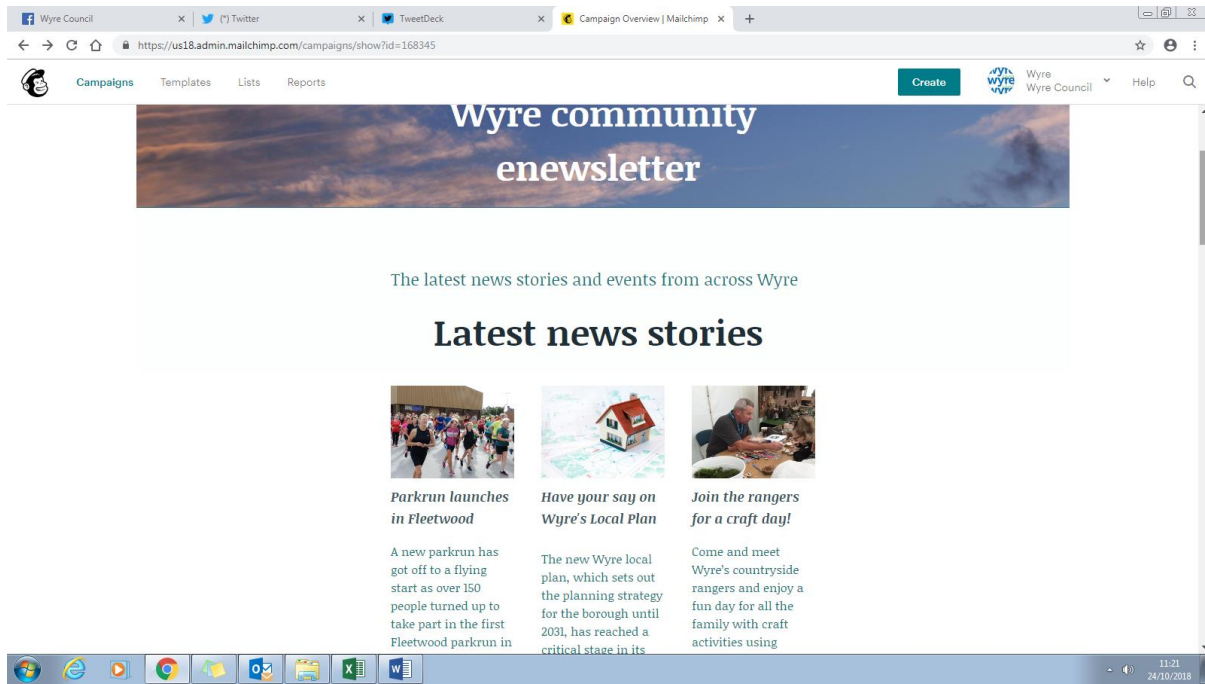

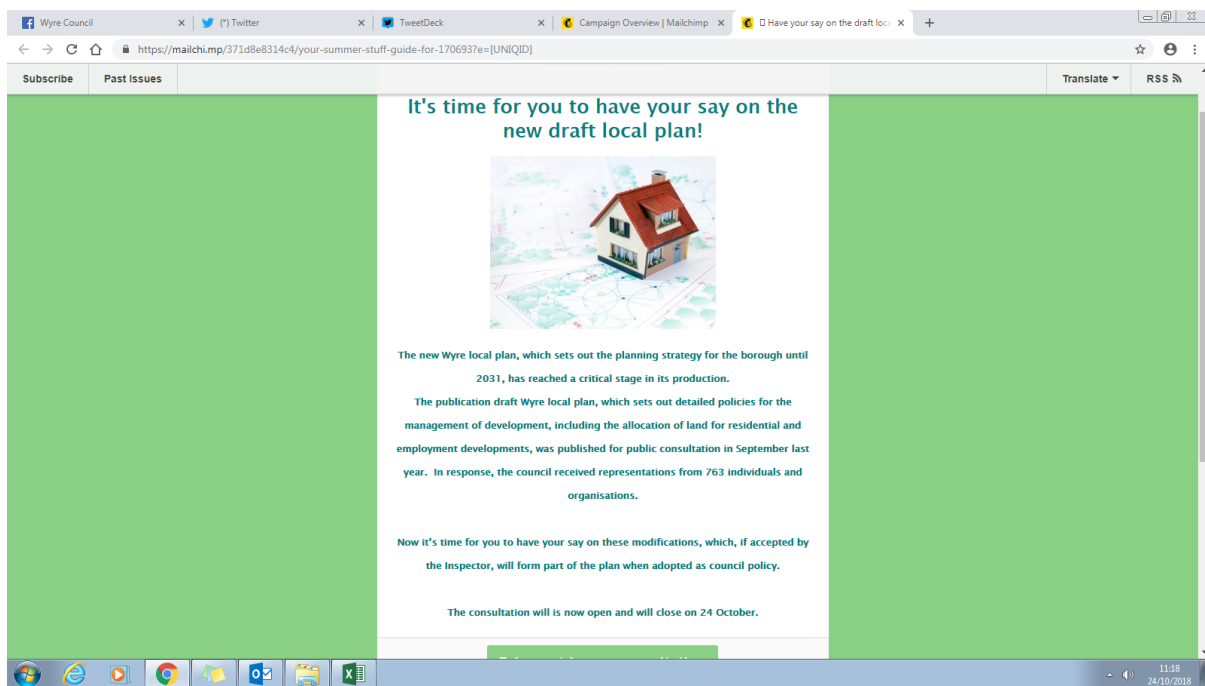

The publication draft Wyre local plan, which sets out detailed policies for the management of development, including the allocation of land for residential and employment developments, was published for public consultation in September last year. In response, the council received representations from 763 individuals and organisations.

The public examination into the Wyre local plan opened on 23 January, with public hearings held from 15 May 2018 to 5 June 2018. Following the council's consideration of representations and issues raised by the examination Inspector and the Inspector's post-hearing advice, the council has proposed main modifications to the local plan.

Now it's time for you to have your say on these modifications, which, if accepted by the Inspector, will form part of the plan when adopted as council policy.

The consultation will take place over a six-week period beginning on 12 September and ending on 24 October.

**What happens now?** Having published the publication draft local plan which has been subject to public hearings lasting two weeks, we are about to enter a six week period of consultation, where you can have your say on the proposed main modifications to the Local Plan.

Comments received at this stage can only relate to the main modifications and accompanying Sustainability Appraisal Addendum 2018. We have published a guidance note which will assist you in completing the consultation and explain the four factors of soundness. You can view this at [www.wyre.gov.uk/localplan](http://www.wyre.gov.uk/localplan)

**So, what will happen next?** Once the six week consultation period has ended on 24 October, the council will submit the responses to the Inspector who will consider the matters raised. As a result he may require further hearings to take place or, alternatively, move to complete his report on the local plan. The plan will then be adopted by full council.

**Q3a** – The proposed Main Modifications have been made to make the Plan “sound”. Through the examination the Inspector will consider whether or not the Local Plan passes the test of “soundness” set by the government’s National Planning Policy Framework (NPPF). The NPPF has recently been revised. Paragraph 214 of the 2018 NPPF states that the policies in the previous 2012 NPPF will apply where the Local Plan has been submitted to the government for examination before 24 January 2019. For the avoidance of doubt, as the Wyre Local Plan was submitted to the government in January 2018 it follows that the policies of the *previous* 2012 NPPF, including the tests of soundness, will apply. Thus the 2018 NPPF has no weight in relation to the emerging Wyre Local Plan and you are strongly advised not to refer to it to support your arguments.

To be found sound a plan has to be:

**Positively prepared** - This means that the Local Plan should be prepared based on a strategy which seeks to meet objectively assessed development and infrastructure requirements, including unmet requirements from neighbouring authorities where it is reasonable to do so and consistent with achieving sustainable development.
